Jack Waldorf reported the committee finalized the BHB agenda for March 28, 2024, meeting. The committee discussed inviting various cultures to the BHB meeting to present on how mental illness is viewed in different cultures at the May board meeting.

Peter Dean reported the committee received a presentation from Outreach & Engagement program.

Substance Use Disorder (SUD) Committee

Margie Johnson reported the committee received a presentation regarding Substance Use Disorder (SUD) from Tracey McCullough, SUD Manager.

DEPARTMENT REPORT

Tony Vartan, BHRS Director reported the following highlights:

- Prop 1 officially passed March 2024, a transformation of Mental Health Services Act (MHSA) to Behavioral Health Services Act (BHSA). The State of California will receive 10 percent of the funding and counties will receive 90 percent which will be divided into 3 portions. Funding will be monitored closely for transparency.
- The current MHSA and BHSA components were compared after passing Prop 1, showing the shifting of funds.
- CARE Act has received 36 petitions with 12 having agreements in place.
- March's 24/7 Mobile Crisis data was reported.
- Johnny's Ambassadors gave a presentation at Stanislaus Family Education Night on March 27, 2024. The presentation educated parents and teens about the dangers of today's high-THC marijuana on adolescent brain development, mental illness, and suicide.
- AB2119 will update and recast mental health disorder terms to reflect current understanding practice in mental health.
- AB2995 will revise and recast various alcohol and other drug abuse terms, to use person-first terminology and focus instead on substance use disorder.
- Working Together for a Safer California Package focuses on both the fentanyl crisis, retail, and community-based crime increasing access to treatment, offering rehabilitative services for those in the criminal justice system, preventing trafficking of dangerous new substances.
- Discussion in creating awareness and focus on issues and challenges Veterans face reintegrating into the community and accessing support.
- Members were encouraged to review the following Senate and Assembly Bills: SB1468, SB910, SB1468 9 &10, AB1437, AB1788, AB1842, SB294, SB402 and SB1184.

PRESENTATION: Substance Use Disorder (SUD) Services

Tabitha Sprague, Chief, Substance Use Disorder Services (SUD), provided a PowerPoint presentation of SUD services. Drug Medi-Cal Organized Delivery System (DMC-ODS), a health plan of network providers responsible for the provision of SUD services to Medi-Cal beneficiaries. The Expansion goal is for every person requesting help to have options for seeking services either by calling or walking-in regardless of pay source. Integrate Mental Health and Substance Use Disorders to educate the community of treatment resources available.
