#### APPROVAL OF MINUTES

#### **BOARD OF SUPERVISORS (BOS) REPORT**

Supervisor Withrow reported the following:

- The BOS received a presentation on the Child Abuse Interview Referrals and Evaluation (CAIRE) program.
- The BOS proclaimed August 31, 2022 as Overdose Awareness Day in Stanislaus County.
- The BOS approved the allocation of \$50 million for five districts with unincorporated areas.
   On September 20, 2022 the BOS will decide which projects will be funded based on community input.

#### PRESENTATION: CENTRAL VALLEY CONTINUUM OF CARE FOR CHILDREN & FAMILIES

Mike DeRose, Aspiranet Division Director, provided a PowerPoint presentation on the Central Valley Continuum of Care for Children and Families:

- Aspiranet submitted a consortium proposal with Stanislaus, Merced and San Joaquin Counties for the Behavioral Health Continuum Infrastructure Program (BCHIP) grant.
- Grant money received will primarily go towards the existing Aspiranet Residential Campus to be renamed "Hope Forward Campus". The 10.5 acre campus will become a community of facilities.
- Three-year development and construction cycles to build multiple new facilities and renovate existing facilities.
- The campus would include program facilities such as a Crisis Stabilization Unit (CSU), Psychiatric Health Facility (PHF) and Short Term Residential Therapeutic Program (STRTP).
- Additionally, the campus will include support and administrative services: recreational center/cafeteria, intake/administrative services, family visitation and service buildings.

A copy of the PowerPoint presentation was distributed to the members.

John Aguirre commented additional respite beds are needed. The lack of beds creates difficulties with placing the homeless after hours and on the weekends.

Larry Bolton reported the committee received a presentation from the Center for Human Services (CHS) regarding their opiate treatment education in the public school systems.

## **DEPARTMENT REPORT**

Kara Anguiano reported the following highlights:

- New Behavioral Health Director, Tony Vartan, started Monday, August 22<sup>nd</sup>.
- BHRS will be moving forward with the California Mental Health Services Authority (CalMHSA)
   Enterprise Electronic Health Record (EHR). The new EHR will reduce staff data entry, be
   consistent with California Advancing and Innovating Medi-Cal (CalAIM) requirements and
   ensure data accessibility and interoperability.
- A public hearing will be held at the next BHB meeting for the MHSA Plan Update FY 2022-2023. The following expansions will be proposed:
  - Permanent supporting housing project "Central Valley Homes" proposing to contribute \$2.4 million in MHSA funds.
  - Community Based Cultural and Ethnic Engagement, expanding MHSA funding by \$520,000 to community-based organizations.
  - o Child Youth Resiliency expansion by \$15,000.
