The Central California LGBTQIA+/2S Collaborative is a (501(c)(3) nonprofit organization serving Stanislaus, Merced and Tuolumne Counties. Our office and advocacy center is located in downtown Modesto where we offer peer support, resources for unhoused persons, systems navigation, systems and personal advocacy, community events, health education and resources, a clothes closet and food pantry. We partner with the Merced Pride Center to provide similar services through them to the Merced LGBTQ community. By the numbers...

- ❖ We were founded in 2015, became a nonprofit in October 2019, opened the doors to our Advocacy Center, October 11, 2021, in honor of National Coming Out Day
- During the month of April 2022, we had 396 persons come through our doors
- Of those 396, about 33% were unduplicated
- Out in the community, during April 2022, we engaged approximately 2500 persons with approximately 40% identifying as LGBTQIA+/2S
- We currently have 10 staff equal to 8 FTE positions, 90% identify as LGBTQ, 50% are Latinx, 40% are bilingual in Spanish/ English, 60% identify as transgender
- ❖ The Queer Health Initiative is comprised of 12 Health Interns who receive stipends, travel and cell reimbursement to conduct Opioid prevention education and distribute Narcan and Fentanyl kits



What do we need...

System that is inclusive of LGBTQ+ peer/ consumers

- ✓ Representation on planning bodies/ committees
- ✓ Representation in BHRS and Provider management and all staff levels
- ✓ BHRS and Provider staff trained in LGBTQ+ cultural humility
- ✓ BHRS and Providers trained on importance and requirement to collect Sexual Orientation, Gender Identity & Expression (SOGIE) data
- ✓ BHRS and Provider forms be written in inclusive non-stigma language
- ✓ BHRS and Providers trained and supported on how to competently and compassionately collect SOGIE data
- ✓ Representation on reports such as MHSA plan and Cultural Competency Plan
- ✓ Focused funding specifically for LGBTQ+ wellness



What do we need...



Services that are LGBTQ+ welcoming & affirming

- ✓ Highlight to client staff that identify as LGBTQ+
- ✓ BHRS and Provider staff familiarized and utilize pronouns that respect gender identities
- ✓ BHRS and Providers celebrate the LGBTQ+ community in their outreach and engagement activities
- ✓ BHRS and Providers show representation of inclusiveness in their offices, centers, meeting rooms
- ✓ Services that are provided through trauma informed lens of LGBTQ+ experiences as sexual minorities
- ✓ Peer Support to LGBTQ+ peer/ consumers from other LGBTQ+ peer/ consumers available as requested
