

COMMITTEE FACT SHEET

NAME: SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT
CITIZENS ADVISORY COMMITTEE (CAC)

ESTABLISHED: November 2, 1996

COMPENSATION: For Governing Board Members: \$100 per meeting, plus mileage
For Governing Board Chairman: \$300 per month

CONFLICT OF INTEREST: Not required

LEGAL AUTHORITY:

MEMBERSHIP: Each Board of Supervisors of the eight member counties appoints two members to the CAC. One member shall represent agriculture or other industry and one shall represent environmental interest groups.
QUALIFICATION AND RESIDENCY REQUIREMENTS: A City Selection Committee in each County of the Valley shall each appoint one member to represent cities of that County.
Each appointing body shall appoint an alternate member for each primary member appointed.
CAC members and alternates must be bona-fide residents of their County.

TERM: Initial term of members appointed by the City Selection Committee is one year. Initial term of Environmental members is two years; Initial term of Industry/Agricultural members is three years. All subsequent appointments shall be for terms of three years. CAC members may be re-appointed to successive terms by their respective appointing bodies.

DUTIES: Primary responsibility of the CAC: "The Advisory Committee shall meet no less than semi-annually for the purpose of receiving public comments relating to the actions and decisions of the District and to assist the District in effectuating its purposes"

MEETINGS: **Governing Board Meetings** will commence at 9:00 a.m. at the Central Region Office, Governing Board Room, 1990 East Gettysburg Avenue, Fresno, Ca Via Video Teleconference (VTC) with the Northern Region Office (Modesto) and the Southern Region Office (Bakersfield) participating Via VTC, on the following dates in 2011: January 13, January 20; February 17; March 17; April 21; May 19; June 16; (No July Meeting); August 18; September 15; October 20 (November Meeting tentative); and December 15. Governing Board meetings are web cast.
Citizens Advisory Committee Meetings are held via video teleconference (VTC) on the first Tuesday of each month, usually at 10:00 a.m., except July and November, at the Central Region Office (Fresno), Governing Board Room, 1990 E. Gettysburg Avenue, with the Northern Region Office (Modesto), 4800 Enterprise Way, VTC Room, and the Southern Region Office (Bakersfield), 2700 M Street, Suite # 275, VTC Room, participating via VTC. CAC meetings are web cast.
