Approved the distribution of existing Public Facility Funds (PFF) in the amount of \$166,660 to the Stanislaus Behavioral Health Center cost Index 108167; approved the percentage amount of 34.9% for the continued distribution of PFF funds on an annual basis as fees are collected; authorized the Auditor-Controller to make the transfer from the PFF to the cost Index 108167; and authorized the Auditor-Controller to annually transfer from the PFF to the Mental Health Fund according to the above-stated percentage as applied to the yearly fees collected

B/C unan. Considered staff report, Board discussion and comments and testimony received during the public hearing and approved the privatization of janitorial services for the Community Services Center and the Public Safety Center after making certain findings that: 1. services under consideration for contracting are "special services" (maintenance or custodial); 2. the sites being served are remote (4.5 miles from County Center I) from available County Employee resources and 3. that the County's economic interests are served by such a contract as set forth in staff report and testimony; selected the proposal submitted by American Building Maintenance Company and approved a three-year contract for janitorial services for the Community Services and Public Safety Centers at an annual cost not to exceed \$208,932 or \$17,411 per month; authorized the CEO to sign the agreement; the Board decided that a competitive approach for certain County services might be an effective way to improve the quality of service and control costs consistent with Board goals and objectives; and with regard to custodial services, the Community Services Center which is a new site remote from other available County employees' sites represents a significant increase in square footage that must be cleaned on a daily basis. The Board noted that janitorial services are provided to County departments both by the Public Works Building Maintenance Division and currently in selected areas by contract janitorial companies. It was concluded in April that contracting for janitorial services in the new Community Services Building (a building four times larger than the County Administration Building) may be an efficient and achievable alternative as the sites are remote from other available County employee resources. Presently, the Board noted it costs about \$120,000 per year for County staff to maintain the County Administration Building which is approximately one quarter the size of the new Community Services Center. The Board further noted and finds that no County employees are being replaced or losing their jobs as a result of the Board action of entering into a contract for custodial services at the new sites and that the services being contracted out are new custodial services. Finally, the Board noted that the action of the Board saved taxpayers money and was fiscally responsible. 94-632 M-65-B-10 (2-215

B/P unan. Based on staff report and recommendation, the Board approved the dissolution of Sherwood Forest Drainage Maintenance District and directed the Auditor-Controller to transfer \$400.00 from the
