C/B unan. Revoked UP #80-19 for Pioneer Speedway a conditional UP in an A-2-10 (general agriculture) zone. The Board suspended the execution of the revocation until the date of 11/1/94 which will allow the Planning Commission and the Board sufficient time to hear the new use permit application. The Board's decision is based after conducting a properly noticed hearing which several witnesses testified both for and against the revocation. The Board based decision upon a review and consideration of staff reports to the Board which included several attachments and have specifically included the transcript of the Planning Commission meeting of 6/16/94 as well as receiving and considering and making their decision based upon the testimony of all the witnesses and all the various documents and photographic evidence and other material and documents which were submitted and reviewed and considered by the Board in making their decision. The Board specifically finds: (1) that the permittee in this instance failed to comply with certain conditions that were set forth in the permit. The Board finds (2) the permit provided that failure to perform any of the stated conditions would constitute grounds for revocation. The Board also finds that (3) there is sufficient and substantial evidence presented from the testimony, documentary evidence and the staff reports that several of the

conditions set forth in the permit were violated. The Board finds (4) evidence of violation include the fact there is substantial evidence that the track has been expanded from that which it was originally approved, and that finding is based upon the evidence and testimony of witnesses, the aerial photographs and other documents which have been introduced and considered by the Board. The Board, further finds that (5) there was substantial evidence showing there has been violation of hours and that operations of the track hours were operated beyond the designated time frames. The Board finds that (6) there have been other violations of the permit including some "light" violations and racing of "go carts". The Board finds (7) there is substantial evidence to support violations of overnight camping. In addition, separately the Board further finds (8) that there is substantial evidence showing violations of permit conditions on the record which, in and of itself, support revocation of the permit. In addition the Board further finds (9) that there has been substantial evidence received on the issue of "nuisance" and the Board finds separate from the permit conditions violations that the business has been conducted in a manner which constitutes a nuisance in the areas overnight camping, parking on neighbors property, "light" violations "go cart" racing as well as violations of hours of operations.

CEO reported the Empire Fire District voted to participate in the Fire Consolidation District. All four fire districts involved have agreed to move forward. The next steps will be to prepare the appropriate applications to LAFCO, prepare the appropriate draft agreements to this agency and the new fire agency,

and to deal with some of the fiscal consolidation and close out issues as we get out of the business and the district gets into it. The CEO will come back to the Board with more detailed reports as we move along.

Supervisor Paul asked for an update on the Graffiti Ordinance. County Counsel responded the Ordinance would be coming to the Board within two weeks - there are still some outstanding issues to resolve. Senator McCorquodale's bill is proceeding rapidly through the State Legislature and is expected to be ratified within two weeks
