additional condition that the applicant will post at the site and prepare a written handout to be provided to all customers that they are to cover the animals with suitable covering to avoid any kind of debris or other droppings of the animals on the roadway when transporting dead animals to the transfer station; the Board bases its decision on the staff report, the testimony of the witnesses at the hearing, according with the documentary evidence that was presented and all other materials that were presented to the Board; the Board also notes that the Turlock facility has been in operation there have been no complaints for approximately the last 2 to 2 1/2 years, certain neighbors in Turlock did testify that there were no problems with the Turlock plant, corroborating the testimony of staff on this matter before the Planning Commission, in addition there was testimony that because of the Turlock facility there were less problems with animals being dumped in about the Turlock area, in addition there was an veterinarian who testified that the problems that were discussed by some individuals would not exist and there were no problems in his experience with the operation of the transfer station; and lastly the Board finds that the necessary findings on this matter can be made that as set forth in the staff report including the uses proposed will not be substantially detrimental to or in conflict with the agricultural use of the property in the vicinity and also that the parcel's use that is requested is not located in one of the County's most productive agricultural area, as that term is used in the Ag Element of the General Plan 95-357 S-30-AG-2 (1-509
