Supervisor Mayfield voiced concerns regarding some of the County Departments' voice mail systems. The CEO said all County voice mail systems would undergo TQM review for user-friendliness and the MIS Director would come back with a report regarding this matter

The CEO recommended a change in the County Code regarding language for "days of mourning" in light of the 11/6/95 Governor's Proclamation request for "a day of mourning" throughout the State for Israel Prime Minister Rabin. The way our ordinance now reads the County is required to give a paid day off for all County employees.

The CEO urged all Boardmembers to review the most recent edition of the CSAC Legislative Bulletin which outlined 81 bills that could impact County government. The CEO staff will review and comment on the bills and make recommendations or adjustments to the 1995/96 Legislative Platform.
