Supervisor Simon requested an advisory committee be formed under the direction of the CEO with two Boardmembers, Planning staff and various local bankers to meet for the purpose of discussing the conditions of the Community Reinvested Act and for low interest rate loans, home improvement loans and remodeling loans. Supervisors Simon and Paul expressed a desire to serve on this advisory committee which will prepare a report for the entire Board on this issue to be brought back at a subsequent Board meeting

The CEO reported on the status of the AB 698, the negative property bailout bill, which is now before the Senate Appropriation Committee and asked for Supervisors to call Senator Johnson. He advise Board he is sending a formal letter to the City of Modesto regarding their Redevelopment Agency with an offer of interest in pursuing the development of a new Courts facility
