The CEO apprised the Board of his trip to the State Capitol in Sacramento with the French interns, Rolland Starn, Josh Bernard, and Marika Blom. They had a good day which included a meeting with Assembly Members Sal Cannella and George House, as well as Senator Monteith.

The CEO updated the Board on AB 698 (carried by Assemblyman Cannella) that would freeze the negative bailout amount to last fiscal year's, was being heard by the Senate Appropriations Committee which is Chaired by Senator Johnson. The CEO and Assemblyman Sal Cannella spoke at the hearing along with our Legislative Consultant, Mr. Peterson, and voiced their concerns on the Chair's reluctance to consider AB 698, however, the CEO felt the issues of fairness which he presented to the committee seemed to have fallen on deaf ears. Also, at this point, all fiscal bills over \$125,000 must go to the Suspense File as they move through the budget process, but the CEO and Assemblyman Cannella will continue to pursue this bill, and it's expected to be released from Suspense File in either September or October of '96.

Supervisor Paul requested the CEO to obtain a list of names of the members on the Senate Appropriations Committee.

The CEO attended a meeting on AB 8 pertaining to AB 2187, the bill which would have taken \$87,000,000 out of San Francisco's allocation and redistributed to other counties in the State, and he spoke with the President of CSAC regarding the development of a fair and equitable redistribution plan of these tax monies.

The CEO reported that the Big Five Committee worked out some of the major issues in relation to the State Budget, but the substance of the budget is contained in the trailer bills which are not expected to be introduced until they return from recess in August. Trial Court Funding remains a hopeful issue, however, the Educational Revenue Fund looks like a dead issue and will not be resolved this year.
