Approved the recommendations of the County Counsel and the Chief Executive Officer regarding the resolutions from the West Stanislaus County Fire Protection District, Salida Fire Protection District and Oakdale Rural Fire Districts regarding the District's desire to withdraw its taxpayers from the "Less than County Wide Fire Service Fund"; find that the Board has received and considered the resolutions of the Boards of Directors for Oakdale, Salida, and West Stanislaus Fire Protection Districts regarding the levy and collection of assessed taxes for fire protection district services; find that the Board of Supervisors determines that it is in the best interests of the County as a whole to continue with the status quo, and find that the Less Than County-Wide Fire Service Fund special tax continue to be levied and collected; find that at present, the Consolidated Fire District will, pursuant to the contract with the County, receive the funds for the Less Than County-Wide Fire Service District, which shall be used for providing all of Stanislaus County's fire districts with fire prevention support, investigation, community and administrative support, and other general services. Find that these services will be made available, along with other services, to the respective districts in Stanislaus County as long as the district exists and as long as the special tax is levied and collected; that the Board finds that the Less Than County-Wide Fire Service Fund was never part of any specific fire district, revenue base, or property tax base, and that these monies have always been separate from individual fire districts' revenue; that the Board further finds and determines that the best use for the County of fire service tax monies is currently to contract with Consolidated Fire to provide the services to the remaining districts in Stanislaus County; that the Board further finds that it is the "availability" of the tax fund to provide these services that is critical, and that there may be no relationship between using the services made available and the amount of money that a particular property owner pays. The critical issue is that the tax monies are "available" to provide these services and that simply because a person does not utilize the service from which tax funds are collected to provide does not operate to require a refund of those services or serve as a basis to stop collection of tax monies; the Board further finds that if the argument of the Districts of Oakdale, Salida, and West Stanislaus are taken to their logical extension, then a citizen in their respective district who has never utilized the services of the district should not be assessed a tax or in any other way made to pay for the services of the fire district; that the Board

encourages all fire districts to work with the Consolidated Fire District to identify services which may be beneficial to each respective district and to remain in contact with the Consolidated Fire District to best utilize the available tax funds to maximize the services which can be provided to the districts by Consolidated Fire through the contract with the County
