Supervisor Paul went to the WIR Conference in Boise, Idaho where she attended a War on Weeds seminar that utilized the GIS System and involved elementary and high school students.

Supervisor Simon asked about the regionalization of the airports in Stanislaus County and San Joaquin County. He asked that the City/County Airport Manager make a report to the Board regarding United Airlines services. He does not want anything to jeopardize United Airlines' services to our airport. The CEO will request the Airport Manager, Howard Cook, to report to the Board.

Supervisor Blom noted that the Retirement Board's stock is up at 8.6% for the year and has done very well. The fund is at \$940 million.

The CEO reported that the new Animal Shelter facilities were operating in March but then closed for a while due to a roof leakage. Additional capital expenses for the Animal Shelter will be reviewed and he recommends looking at moving the shelter to the Safety Center. He noted that the County was notified by the State that the \$2 million MediCal room charge claim would be denied. The County will be pursuing a legislative solution and/or other resolutions to this issue. He requested the Board become involved in contacting the Governor and the State Legislature regarding this matter.
