Bill Cox spoke regarding his wish to have the County continue with overseeing the cleanup efforts at the Westely tire fire site.

Karen Cox spoke on behalf of the Westley Citizens Committee's concerns regarding health issues, responsible cleanup, and looking into statewide alternative recycling methods of waste tires already implemented in states such as Hawaii, Arizona, and Minnesota. She requested that a health study be conducted as to the health effects on the children in the three schools affected and that mechanisms be implemented to expedite warnings to the public of the various health effects and dangers in the event of a similar hazard occurring in the future. She also requested

the County to continue encouraging the State to speed the cleanup of the site and to characterize exactly what type of waste product it should fall under.

John Mataka spoke regarding his concerns relating to the thorough cleanup of the buried tires still located at the staging/platform area that was used to burn the tires.

Supervisor Paul returned at 11:20 a.m.

Referred to the Chief Probation Officer a letter from the State Board of Corrections finding that Stanislaus County continues to successfully mitigate the crowded conditions that exist at the juvenile hall by adjustments to the facilities' programs, staffing and operations.

Referred to the DER and to the Agricultural Commissioner the State Water Resources Control Board's Notice of Petition for Temporary Change involving the transfer of 75,000 acre-feet of water to the United States Bureau of Reclamation for use within seven counties, including Stanislaus County.

B/P unan. Accepted report from the U.S. Fish and Wildlife Service regarding the availability for public comment of the draft California Red-legged Frog Recovery Plan and accepted a copy of the plan; and, referred the report and plan to the Agricultural Commissioner 2000-453

P/S unan. Accepted the Stanislaus County 1999-2000 Civil Grand Jury Final Report Part Twelve for the Valley Home Fire Protection District Valley Home Fire Association 2000-454

Supervisor Paul requested that a letter be sent to the Grand Jury Foreman to clarify the division of legislative responsibilities and the rules and regulations that govern this Board's realm of authority over the special districts and elected officials to such boards. The CEO stated that he would follow-up with an appropriate letter.

Referred to the DER and the Agricultural Commissioner letters from the University of California, Davis; California Department of Fish and Game (two letters); and, United States Department of Agriculture regarding their intent to submit a proposal to the CALFED program for funding.

Acknowledged receipt of claims and referred to the CEO-Risk Management the following claims: Angel Herrera, Athena Herrera and Angel Herrera by & through their guardian ad litem Angel Herrera; Thomas Hawkins, Jr.; Jorge Octavio Salcedo Rivas, Jr., a minor; Margaret Gonzalez; Lucy Susan Johnson; and, Albert J. Villarrial.

Supervisor Paul absent at 11:57 a.m.

Supervisor Blom stated that he continues to receive many complaints regarding the limited timeframe set by the Clerk-Recorder for obtaining passports and requested a report be brought back to the Board on how this is progressing.

Supervisor Simon commented on this morning's newspaper article regarding the loss of another major telephone business in the area and SCEDCO's comments about the lack of available buildings to fit the size required for such companies and, inquired as to whether there are contractors who build speculative 50,000 square foot buildings prior to having a buyer/lessee. In addition, he voiced his concern over SCEDCO's statement in the article which seemed to imply that the County doesn't have a fast tracking permit system, and stated that this assumption is inaccurate information that needs to be corrected due to the newspaper being widely read by people willing to locate within the County.

The CEO pointed out that the County has gone through a series of studies and has identified land that is appropriate for industrial zoning and, is currently in the EIR process on the West Side, Salida and Keyes areas in terms of appropriate zoning. He also stated that staff has been directed to look at ways to address the in-ground infrastructure so that in the event someone does want to come in and speculate, all they would need to do is erect a building. He said the County is currently in the process of making this a viable option.

Supervisor Mayfield commented on the article regarding mitigation of pollution in the valley and the expense involved.
