Approved the subdivision improvements of Oakmore Estates Subdivision, Phase 1; find that all subdivision improvements required for Oakmore Estates Subdivision, Phase 1, by the subdivision improvement agreement, executed by Bruce Boese, Rhonda Boese and the Stanislaus County Board of Supervisors on 12/7/99, have been constructed to the satisfaction of Stanislaus County (said agreement was recorded 1/11/00, as Document No. 2000-002287, Stanislaus County Records); accepted all streets, avenues, roads, and the drainage system within Oakmore Estates Subdivision, Phase 1, for maintenance by Stanislaus County; pursuant to §66499.7(a) of the Subdivision Map Act, authorized the release of the Irrevocable Letter of Credit No. CCB1999-7 that was issued by Central California Bank in the amount of \$143,000.00 for faithful performance of the subdivision improvement agreement; and, pursuant to §66499.7(b) of the Subdivision Map Act, upon receipt of a Mechanic's Lien Guarantee, authorized the release of Irrevocable Letter of Credit No. CCB1999-8 that was issued by Central California Bank in the amount of \$71,500.00 for payment of labor and materials, the Mechanic's Lien Guarantee must be dated a minimum of 35 days after the filing of the appropriate Notice of Completion; be in the amount of \$71,500.00; be prepared by a title company; be to the benefit of Stanislaus County; and state that there are no liens of record

Supervisor Paul participated in the Annual DARE Golf Tournament and requested a report from the Sheriff on the success of this program. She noted the Children and Families First Commission would be holding a public hearing on their Strategic Plan by the Renaissance Group on 8/30/00 at 5:30 p.m.

Supervisor Mayfield noted that the Waste-to-Energy Committee met, but the appraisal of the facility has not been completed. The burning of the medical waste issue was discussed and the CEO commented that utilizing the Waste-to-Energy Plant is a safe way of disposing of this waste product.

The CEO gave a report on the 1999-2000 Stanislaus County Volunteer Services Program.

The CEO sought input on the 2000-2001 Final Budget.
