Chairman Caruso noted that on Friday he attended the Symposium on Leveraging the Potential of Your Community, and he had the honor of welcoming former U.S. Secretary of Housing, Henry Cisnerios.

The CEO informed the Board that the County will be receiving a \$545,000 increase in our Homeless Mental Illness Programs allocation and in subsequent years our allocation will move from \$2.7 to \$3.5 million per year based on the success of the program at the State level. He informed the Board of the sale of our Tax Revenue and Anticipation Notes (TRANS) of \$27 million at a net interest rate of 3.744%. Standard and Poors gave the County an A rating for the sale of the TRANS.

Don Donaldson spoke to the Board regarding issues with his renter at his rental property on 2309 Chili Avenue in Ceres.
