- *C1 Approved the Plans and Specifications for the Albers Road Widening Project from Claribel Road to Warnerville Road; set the deadline for submission of bids as 5/1/02, prior to 2:30 p.m.; directed Public Works' staff to mail the Notice Inviting Bids to Trade Journals as required by law; and, directed the Auditor-Controller to increase appropriations by \$3,000 in the project account to cover the costs of advertising and publishing – PW 2002-185
- *C2 The Board finds that Ordinance C.S. 789 amending Title 11 of the County Code to add No Parking Zones on Coffee Road, CrowsLanding Road and Frazine Road, and amending an existing No Parking Zone on Imperial Avenue, is not subject to the CEQA; and, introduced and waived the first reading of Ordinance C.S. 789 ORD-54-J-7 2002-186
- ***D1** Set a public hearing on 4/16/02, at 7:35 p.m., for Rezone Application #2001-19 Ray Gritton 2002-187
- *D2 Rescinded Williamson Act Contract #91-4213 and approved 2 new contracts pursuant to Minor Lot Line Adjustment Application 2002-01; authorized the Planning Director to execute new contracts; finds the new contract or contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the acreage restricted. In cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in §51222; finds the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; finds the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan 2002-188
