Ken Patterson, Director of CSA, and Dan Souza, Director of BHRS, presented a resolution proclaiming Social Worker Recognition Month.

Kristi Rosenquist, from the United Domestic Workers (UDW), stated that they are taking Supervisor Simon up on his offer to assist them in going to Sacramento on 4/22/04. She spoke regarding the labor negotiations with the County and said that they are aware of the cost to County, State and Federal government to give the caregivers a raise. She noted that if caregivers were given a raise, it would bring more income to the County. Based on a UDW Economic Impact Report, she anticipates that in the first year, the impact would be \$15 million.

Supervisor Paul announced that she is engaged and will get married in October, 2004.

Supervisor Grover, Chair of the Local Task Force on Solid Waste (LTF), spoke regarding recent LTF meetings about the State mandated update of the Countywide Siting Element. He also spoke regarding recent articles and an editorial in the Modesto Bee concerning the update of the Siting Element and expansion of the Fink Road Landfill. He noted that the County had not been successful in convincing the community that there are no plans for a mega-dump or to privatize the landfill, even though the County proposed to put limitations in the updated Siting Element to prevent that from occurring. Supervisor Grover discussed a meeting with staff and Supervisor Caruso held on Monday, 3/22/04, on the Siting Element update and the proposed expansion. He indicated that he will recommend, along with staff, that the Board consider approving submission of an update of the Siting Element, which includes a map that outlines only the proposed 129-acre Canyon Landfill Alternative expansion project with additional area for access roads and placement of dirt for excavation around the landfill totaling less than 300 acres. He indicated that it is his belief that this limited expansion with lines drawn around the expansion on the siting map should eliminate citizens' concern regarding expansion at the landfill. He also indicated that along with the map showing the limited 129-acre expansion impact, the Siting Element update will include language clarifying that the County has no intent to privatize this landfill or expand the landfill at this time other than the 129-acre Canyon Landfill Alternative. Supervisor Grover also indicated that the

process is to move forward with the preparation of the Siting Element update that shows only the 129-acre expansion, and includes appropriate limiting language, share the update and all information with the nine cities, and then bring the Siting Element update back to the Board of Supervisors at a public meeting prior to the matter being submitted to the Integrated Waste Management Board by the Board of Supervisors. Supervisor Grover noted that the public would have an opportunity to comment on the Siting Element update and that the public would be able to see that the proposed expansion is a very limited one, which should dispel the false rumors of a large landfill expansion. Supervisor Grover indicated that the intention of the County is to provide for long-term landfill needs of the County.

The Board members discussed Supervisor Grover's comments and the proposed limited expansion of the Fink Road Landfill. Board members indicated that the Department of Environmental Resources should bring this matter back to the Board of Supervisors at the Board meeting of 4/27/04 for the Board to consider approving the update of the Siting Element, including the Siting Element map showing limited expansion, along with language which discusses the limited expansion. The Board wanted this matter to be discussed in public before deciding whether to approve sending the Siting Element update to the State for processing.

Board members also commented about the articles in the Modesto Bee and the misinformation and false impression that is being portrayed about the proposed expansion. Chairman Caruso noted that the issue of perception is important, that politics had unfortunately been brought into this issue, and that the Modesto Bee articles and other newspapers did not accurately portray the Board action on this matter. Supervisor Caruso noted that adoption of a Siting Element does not entitle development or expansion of a landfill and that compliance with CEQA is also required. He indicated that he believes Supervisor Grover's idea to bring the limited expansion map for Board consideration on 4/27/04 is necessary to give the public confidence that a large landfill expansion is not being considered by the Board.

Supervisor Mayfield also commented on the newspaper articles in the Modesto Bee. Supervisor Mayfield wanted to make it very clear that this current Board of Supervisors never voted for a "mega-dump," and voted years ago not to bring in any medical waste. He requested staff to produce documents at the 4/27/04 Board meeting regarding the sale of property from Mr. Vogel to the County.

The Chairman noted that the Federal Court in Sacramento has made a decision regarding the Diablo Grande project. County Counsel noted that the Federal Court ruled against the plaintiffs in favor of Diablo Grande and the Army Corp of Engineers.

Supervisor Mayfield noted that the San Joaquin Air Pollution Control District is being sued by Protect Our Air regarding the air quality status being changed from severe to extreme.
