Board of Supervisors Meeting Supervisor Grover absent Pledge of Allegiance to the Flag Tuesday

August 24, 2004

The Chairman presented an Employee Service Award for 40 years to Donna Webster from Child Support Services.

A resolution proclaiming September 2004 as Library Card Sign-Up Month was presented to Stanislaus County Librarian Vanessa Czopek.

Carmen Sabatino asked why the Board was hiring a new County CEO before the new Board members take office. He also spoke regarding past Civil Grand Jury Reports. County Counsel responded that the allegations made are in the past, were investigated, and have been addressed by the Board and County staff. County Counsel also pointed out that despite his numerous allegations, Mr. Sabatino is the only one facing 11 felony counts and criminal action.

Henry Dill noted that the labor negotiations for IHSS employees between the County and the UDW are progressing, and appear to be in the final stages. He requested continued support from the Board for a wage increase. He also spoke regarding a stray dog problem in his neighborhood, and voiced concerns with County Animal Services. Michael Rodriguez, Director of Animal Services, will meet with Mr. Dill to address the stray dog issue.

Naria Jordan of the UDW, thanked the Board for its leadership in the labor negotiations between the County and the UDW. She anticipates that the negotiations will conclude soon.
