He noted that he met with Captain DeLeon, two Sergeants, two nurses and Dr. Cantrell regarding his wife's care. He provided copies of a document to the Board regarding different options for his wife. Captain DeLeon noted that all of the inmates at the Public Safety Center receive medical care. He has looked into this issue and reassured the Board and Mr. Miller that his wife is getting the medical care that she needs.

Supervisor O'Brien gave a Safety Board update and reported that the 4th Quarter Report for 2005 shows that every County department is 100% compliant.

Supervisor DeMartini will be going to the Patterson City Council meeting tonight where they will be considering a MOU with the County concerning the surface water project for Crows Landing in conjunction with the City of Patterson. He asked for an update on the Shackelford area sewer hook-up project. The CEO noted that he would provide Supervisor DeMartini with updated information regarding this project.

The CEO reported that the Federal Budget Reconciliation Bill was passed by the House last week, and that it will significantly impact local government including a reduction in funding for child support enforcement programs. The Director of Child Support Services is working with state and federal representatives trying to develop a solution to maintain the high quality of service provided. The CEO anticipates that the County's Federal and State Legislative Platform for 2006 will be brought to the Board for consideration next week. He also noted that he, along with Supervisor Grover, Supervisor O'Brien, and the Director of Communications and Legislative Affairs will be going to Washington D.C. next week to speak with our federal representatives.
