Supervisor DeMartini spoke regarding the importance and the need for the water project in the Crows Landing area. He noted that by partnering with the City of Patterson, it would be a cost effective way to bring reliable and secure water supplies into the new industrial park and also to alleviate the problems that Crows Landing has with its water supply. In addition, he reported that the Airport Advisory Committee is moving ahead with airport infrastructure improvements and plans to build 50 new aircraft hangers using funds from property taxes on aircraft. He noted that these hangers would also generate rent money, which will help improve the airport. He is glad the Board agreed last year to give back the County's share of property tax money to the airport for these needed improvements.

The CEO reported that he, Supervisor O'Brien, Supervisor Grover and the Director of Communications and Legislative Affairs leave tomorrow for Washington D.C. to meet with our federal representatives. He noted that AB959-Frommer regarding certified public expenditures has passed the Assembly and has moved to the State Senate, and that SB9-Denham regarding the negative bail-out, is in a Senate Appropriations Suspense file. He gave a brief overview of the County's 2006 State and Federal Legislative Platform as proposed.

Grover/O'Brien unan. Legislative A. Approved the Stanislaus County 2006 Legislative Platform as **amended** to strike Item No.3, on page 14, regarding Food Stamp Fingerprint Requirements
