The CEO announced that Mary Ann Lee has been appointed as the new HSA Managing Director. He acknowledged the extraordinary efforts of those individuals who responded to the heat crisis last week, especially Dr. Walker - Public Health Officer, Gary Hinshaw - Assistant Director of OES and David Jones - Communication Manager.
