Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

August 15, 2006

David Ingersoll, Director of Child Support Services, gave a presentation regarding August 2006 as Child Support Awareness Month.

John Mataka, representing the Grayson Neighborhood Council, spoke regarding the recycling center at the landfill in Monterey. He noted that this recycling center reduced the amount of garbage going into that landfill by 35%. He requested an update concerning whether the County will be doing something similar at the Fink Road Landfill.

Erica Swinney of Green Action for Health and Environmental Justice spoke regarding research and outreach programs concerning recycling as a viable economic development strategy.

The Chairman requested that the County staff who visited the Monterey recycling facility report back to the Board at a future date. George Stillman, Director of Public Works, stated that staff is close to having a recommendation to present to the Board, and are currently working with the smaller cities. He noted that Monterey has a great recycling process, and has the advantage of controlling the entire waste stream in their county.
