- *C2 Approved the annexation of territory (Innovative Technology Business Park Phase 2, APN: 136-008-014 and 136-008-015) to the Salida Highway Lighting District without an election; finds that the territory more particularly described in Exhibits "A" and "B" is owned by petitioner, and that petitioner ownership represents 100% of the total assessed valuation of all taxable property within the territory proposed to be annexed into said district; finds that Stanislaus County Code §21.40.040 requires the installation of a street lighting system to serve the territory; finds that the territory proposed to be annexed is not within the limits of any other lighting district; finds that the public necessity and welfare require that the territory be annexed to the lighting district; ordered that the requirements of notice, hearing and election shall not be applicable to this proceeding, pursuant to Streets and Highways Code §19056; ordered that the territory be annexed to the Salida Highway Lighting District of Stanislaus County; finds the fact of filing of the petition was received by the Clerk of the Board on 8/16/06; ordered that, pursuant to the Streets and Highways Code §19000, et seq., the cost of conducting and maintaining the lighting district shall be assessed against the individual parcels of land within the district's boundaries; directed the Clerk of the Board of Supervisors to send a certified copy of the resolution ordering the annexation to the lighting district to the Department of Public Works, the offices of the Assessor, Elections, Auditor-Controller, and the Clerk Recorder; and, directed the Department of Public Works to send a certified copy of the resolution ordering the annexation to the lighting district and all other required documents and the processing fee to the State Board of Equalization – PW DL-3-B-19
- *D1 Rescinded all or a portion of Williamson Act Contract 1971-0222 (Alvarado Road, South of Oakdale) and approved a new contract pursuant to Minor Lot Line Adjustment 2006-29 (Lutz) and authorized the Planning Director to execute new contracts; finds the new contract or contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the acreage restricted in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in §51222; finds the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; and, finds the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan – Planning

Grover/Mayfield unan. 9:15am Finds Rezone Application #2005-15, Carmax, a request to rezone 9.56 acres of two expired PD (Planned Development) zones, located on four parcels with a new PD zone to allow construction and operation of an automobile sales and service dealership, located at the northeast corner of McHenry Avenue (SR 108) and Claratina Avenue, in the Modesto area, to be "de minimis" for the purposes of collection of Fish and Game fees pursuant to California Code of Regulations §753.5, by adopting the Findings of Fact contained in the attached Certificate of Fee Exemption, those findings being based on the analyses presented in the initial study, and ordered the filing of the Certificate of Fee Exemption with the Stanislaus County Clerk-Recorder's office; adopted the Negative Declaration pursuant to CEQA Guidelines \$15074(b), by finding that on the basis of the whole record, including the initial study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Negative Declaration reflects Stanislaus County's independent judgment and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder's office pursuant to Public Resources Code §21152 and CEQA Guidelines §15075; finds that: (a) the project is consistent with the overall goals and policies of the County General Plan, (b) the proposed Planned Development zoning is consistent with the Planned Development General Plan description, (c) the proposed project will increase activity in the vicinity, thereby necessitating dedications and improvements; approved Rezone Application #2005-15 - Carmax, subject to the attached Development Schedule and amended Development Standards which will include the Stanislaus County Department of Public Works revised conditions as stated in the letter dated 8/10/06; and, introduced and waived the reading and adopted Ordinance C.S. 965 for the approved Rezone Application #2005-15 - Planning ORD-55-3; 2006-681 & 2006-682
