The CEO reported that AB 2486 concerning criminal background checks for registry applicants for IHSS Program, AB 2253 regarding steeper penalties on illegal dumping, and AB 959 regarding certified public expenditures for health clinic systems are on the Governor's desk. CEO Robinson noted that he has written letters to State agencies opposing the modification of the allocation methodology for AB 142, which resulted in the exclusion of Stanislaus County from access to funding for levee repair and replacements. In addition, he provided an update regarding AB 1634 concerning reimbursement for the special election conducted last October.

Deputy County Counsel Dean Wright gave an update regarding the State mandated Medical Marijuana Card program in Stanislaus County. He noted that the program is being developed in this County and that Public Health will return to the Board once it is ready for implementation. He clarified that the County's policy is not to allow the distribution of medical marijuana, but to issue Medical Marijuana Cards as required by the State.

Corr 1 Referred to HSA and County Counsel, two letters from the City of Modesto Police Department on behalf of the Law Enforcement Executive Association (LEX) opposing the issuance of Medical Marijuana Cards and the syringe distribution programs without additional controls.

Corr 2 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Robin M. Stanley and Caroline Michaelis.
