The CEO reported that there has been no action taken on the part of the State administration or legislature to address the multibillion dollar State Budget gap. He stated that the Governor's FY 2009/10 Budget Proposal will be released next Tuesday. He noted that one of the proposals is to eliminate the Williamson Act subvention, which would cost approximately \$1.5 million to Stanislaus County and \$35 million statewide. The elimination of the Williamson Act Subvention Program could lead to significant adverse consequences to agriculture in Stanislaus County and throughout the State.

Chairman DeMartini reported that he received information from CSAC yesterday regarding the State considering withholding funds for social services for the counties for seven months. The CEO responded that they are looking into this issue, but that it does not appear to be implementable, because it would essentially shut down many if not all of the social services throughout the State.
