The Sheriff's Department was presented with a branding iron from the Stanislaus County Advisory Board on Substance Abuse Programs for picnic tables made by the Honor Farm.

The Chief Probation Officer reported that he was notified last Friday that Stanislaus County was successful in securing \$18 million in State money to assist with building a youth treatment facility.

Robert Stanford spoke regarding unregulated and illegal needle exchanges taking place in the community. He has notified both Sheriff Christianson and Chief Wasden regarding this situation. Chairman DeMartini and the CEO stated that the County will look into this issue.

- \*C1 Set a public hearing on 04/14/2009 at 9:20 a.m., or as soon thereafter as the matter may be heard, regarding the formation of the North McHenry #2 Lighting District and the levy of a specific benefit assessment; approved the Engineer's Report for the formation of the North McHenry #2 Lighting District; authorized an Assessment Ballot Procedure in conformance with Proposition 218 for the North McHenry #2 Lighting District; and, ordered that notice of the Public Hearing be given pursuant to Government Code §57353(B), and the Highway Lighting District Act Code §19050 PW
- \*C2 Accepted the offer of dedication of Road "C" (Harding Road) through Lots 33-37, as offered on the Palmbrook Colony Map located west of Turlock; and, authorized the Director of Public Works to record a Certificate of Acceptance with the Stanislaus County Recorder's Office for the Public Utility Easement (PUE) PW
- **\*D1** Rescinded a portion of Williamson Act Contract No. 77-2827, all of Williamson Act Contract No. 78-3069, and a portion of Williamson Act Contract No. 78-3333 (all located on N. Kilroy Road, in Turlock) and approved new contracts pursuant to minor Lot Line Adjustment No. 2008-16 - James J. and Norma N. Fernandez Family L.P., and authorized the Planning Director to execute new contracts; finds the new contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the acreage restricted. In cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in §51222; finds the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; and, finds the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan – Planning 2009-139

Grover/Monteith unan. **\*B8** Authorized the Auditor-Controller to increase appropriations and estimated revenues in the amount of \$93,464.11 in the Sheriff's Operations budget for the Air Support Unit for FY 2008-2009 as detailed in the budget journal; authorized the sole source procurement of the Aero Computer Moving Map system using combined grant funds from the High Intensity Drug Trafficking Area (HIDTA) grant and the "It's All About Methamphetamine Enforcement and Education" grant; and, authorized the Purchasing Agent to issue a purchase order to Hangar One Avionics in the amount of \$93,464.11 – Sheriff 2009-142

Monteith/O'Brien unan. **B9** Authorized the increase in appropriations in the Clerk-Recorder - Elections Division budget for the costs associated with the Statewide Special Election on 05/19/2009 funded from a transfer from Appropriations for Contingencies of up to \$560,000 by 4/5 Vote of the BOS; authorized the transfer of estimated savings from the Clerk-Recorder - Recorder Division budget to the Clerk-Recorder -Elections Division budget in the sum of \$60,000; and, authorized the Auditor-Controller to make the necessary budget adjustments per the budget journal – Clerk-Recorder 2009-143

Grover/O'Brien unan. 9:25 am Finds that the notice of the public hearing was given pursuant to Government Code §6061, Streets and Highway Code §22552 & 19052; conducted the public hearing to receive comments regarding: a) the formation of the Beard Industrial Lighting District; b) the proposed method for calculating the amount of the annual assessment; and, c) the levy of the annual assessment to pay for the street lighting service; authorized the Clerk of the Board to oversee the tabulation of the concealed ballots, tabulate and immediately submit the results to the Board of Supervisors; the Clerk announced that the ballot passed by a majority of landowners in support of the formation of the Beard Industrial Lighting District and the proposed method for calculating the annual assessment (support: 15 ballots, 77.52 weighted votes; protest: 0 ballots, 0 weighted votes; incomplete: 1 ballot, 4.55 weighted votes); the Board finds that all the parcels within the Beard Industrial Lighting District will receive equal benefit from the formation of the district; formed the Beard Industrial Lighting District and confirmed the boundary of the district as those being described on Exhibits "A" and "B", which are made a part hereof; directed the Department of Public Works to file the formation with the California State Board of Equalization; confirmed and approved the method of calculating the amount of the annual assessment that will be used to pay for street lighting service; set the 2009/2010 annual assessments at \$25.21 per Equivalent Benefit Unit (EBU) per parcel (the parcels subject to the annual assessments are shown on Exhibit "C", which is a part hereof); authorized the Auditor-Controller to add the annual assessment to the 2009-2010 Tax Roll; and, made the Engineer's Report a part of the record of this proceeding - PW

Chairman DeMartini voiced his concerns regarding the number of businesses that are closing locally.

The CEO gave a legislative update regarding the Federal Omnibus bill that passed and is waiting for the President's signature. This bill is funding two Stanislaus County projects: the radio interoperability for \$500,000 and the Orestimba Creek Project for \$344,000. The County is hopeful but doubtful that we will receive reimbursement from the State for the Special Election that will be held in May 2009 but will continue to pursue reimbursement. The State is still not releasing funds for cash flow, which impacts the Empire Pool and Tuolumne River Regional Park projects. Five water bonds bills that have been introduced in the State Legislature and the Delta will be a hot topic in the 2009 Session. There are a number of County bills that are pending, and a status list is forthcoming. One bill of significance is the Negative Bailout bill from Senator Cogdill. The County is hosting representatives from Senator Padilla's office and a consultant from the Senate's Natural Resources Committee for a tour of the County's Wasteto-Energy facility. Propositions under consideration that are of community concern is Proposition 1A that will create a "rainy day" fund and put limits on State spending growth; Proposition 1B that would re-alter State payment schedules for Proposition 98 funds which are owed to K-14 school districts which equal \$9.3 billion; Proposition 1C that would allow the State to borrow money for the General fund and securitize it from future revenue from the California Lottery; Proposition 1D that would shift, for 5 years, half to two-thirds of the Cigarette Tax away from the California Childrens and Families Program (Proposition 10 funding) into the State General Fund; Proposition 1E that would amend the Millionaire Tax for mental health services (Proposition 63) and shift revenue from local programs to the benefit of the State General Fund; and, Proposition 1F that would forbid the California Citizen's Compensation Commission from raising Legislators and State Officers salaries whenever the State is running at a deficit. These Propositions are tied to the State Budget that was approved by the Legislature and the Governor.

The CEO announced that there will be a Stanislaus County Board of Supervisors Planning Workshop on Friday, 03/06/2009 between 8:00 a.m. to 3:00 p.m. at Samaritan Village, 7700 Fox Road, Hughson, California.
