Chairman DeMartini reported that he and Supervisor Chiesa attended the grand opening of the new Ceres Community Center, which includes new Council Chambers, earlier today.

Supervisor O'Brien noted that the opening of the Regional Water Safety Training Center in Empire occurred last Friday.

The CEO reported that based on the recommendations from Congressman Cardoza and Senator Feinstein, the House Appropriations Commerce Justice Science Sub-Committee has approved \$250,000 for the Stanislaus County-City of Modesto Radio Interoperability Project. He gave an update regarding the State Budget and noted that the State Legislature missed their 6/15/2009 budget deadline and has a new target date of 6/30/2009. The projections for the State reflect a \$2.3 billion deficit by 7/31/2009 and more than \$18 billion deficit by October 2009 if a balanced budget has not been approved by then. The White House has rejected California's request for federal bailout money, citing that it would set a precedent for other States. Stanislaus County has delivered the impacts of the State budget on the County to our State delegation including the elimination of the Williamson Act Subventions and highway users tax funding, and the delay of a portion of Prop 42 funding. He reported that Stanislaus has its first confirmed case of H1N1. He reminded the public that this is West Nile Virus season and to take appropriate precautions against mosquitoes, and noted that additional information can be accessed at the stanemergency.com website.

Chairman DeMartini asked for an update regarding the court case where the State was not able to take Redevelopment Agency funds. The CEO responded that there has been no determination yet on whether the State will appeal the Superior Court's decision. However, there is an effort to develop a work-around that would still enable the State to take the \$350 million in Redevelopment Agency funds, and discussions are on-going.
