(b) at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts. (c) after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Section 51222. (d) the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands

subject to a contract or contracts. (e) the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use. Chairman DeMartini reported on the Clean-Up day in the Schackelford area and thanked the volunteers, the Sheriff's Department, CEO Department and the Department of Planning and Community Development for their efforts. He noted that at the next Board meeting another adoptable dog and cat will be highlighted from the Animal Shelter.

The CEO reported on the Federal SAFETEA-LU, the transportation bill will move forward under a continuing resolution and it won't be passed until after next year's election. The Governor has signed 478 out of the 707 bills as the water discussions are moving forward in a positive way. The bills that were signed including SB 65, clean-up legislation regarding highway user tax, allowing back payments to be made by the end of the month. These payments will fund our transportation programs but there are still concerns about the long-term funding for County roadways. SB67, a clean-up bill for Proposition 1A is still floundering. Senator Cogdill's bill, SB 85, which will provide Stanislaus County with some nominal relief from the negative bail out which would provide up to \$200,000 per year. He noted that Stanislaus County has paid to the State over \$50 million of local property taxes over the years since the early 1980s.

The Chairman announced that the 21st Annual Equal Rights Awards Ceremony will be held on Wednesday, 10/21/2009 at 3:00 p.m. in the Basement Chambers at 1010 10th Street, Modesto, CA
