Supervisor Chiesa gave an update regarding the CSAC conference that he and Chairman DeMartini attended last week. He noted that the conference was informational and that presentations were given that the Board may need to discuss in the future, including potentially supporting the California Forward. He also noted that there are 60 ballot measures currently trying to qualify, and that they expect 20 measures to make it onto the ballot.

Chairman DeMartini reported that although there is disagreement among Supervisors statewide on how to solve some of the problems, there is a consensus that the State needs to stop taking local government funds.

The CEO announced that there will be a Groundbreaking Ceremony for the new Animal Services Facility on Tuesday, 12/08/2009 at 1:30 p.m. on Crows Landing Road and Cornucopia Way, Modesto, CA.
