Supervisor De Martini noted that last night the West Side Health Care Task Force's Healthy Life Style grand prize award was presented to a Patterson High School senior. The Healthy Life Style contest was an essay and art competition where three high schools, Gustine, Newman and Patterson, competed. The competition is the outreach and educational aspect of the Taskforce.

Supervisor Chiesa invited citizens to a Town Hall meeting that will be held on February 24, 2011, at the War Memorial on 247 E. Canal Drive in Turlock, CA from 6:00 p.m. to 8:00 p.m. He noted that all levels of government will be represented at the meeting. He said that members from the Federal, State, County, City, Schools and Irrigation District will be at the Town Hall to meet with the citizens and for them to ask questions of their elected officials. He added that if the meeting went well he would hold a similar Town Hall meeting in the City of Hughson.

The CEO reported that the County is working on their lobbying efforts at the Federal and State level. He noted that the Legislature is busy regarding the State's budget where there is an intent to define budget cuts to meet the Governor's March deadline. Realignment will be a critical issue and CSAC, with affiliate organizations, are working with the administration and the Legislature to develop a course of action for the program realignment. The realignment may include public safety and human services programs that could be far-reaching and could have significant impact on the local and state relationships. The County is working directly with the Committee and will be actively involved in this process.
