The CEO reported that AB 286 (Bill Berryhill), which would use the proceeds from the sale of excess properties for the former Oakdale By-pass for the North County Corridor in Stanislaus County, passed the Assembly Transportation Committee. He noted that Assembly Member Kristen Olsen has authored AB 890, which would make minor changes to CEQA. He reported that the State Budget is in disarray and that there is no solution on the horizon, and that there is little progress on the development of a Federal Budget as well.
