Supervisor Chiesa spoke regarding Correspondence No. 1 on today's agenda, concerning Realignment and the transfer of the supervision for lower-level criminal offenders and parolees from the State to counties, and noted that the State is providing funding for only 9 months. He gave an update regarding CSAC's concerns about the impact of Realignment on counties, and in not having constitutionally protected funding. He suggested reading the 09/07/11 editorial in the LA Times regarding this issue.

The CEO reported that the State Legislature has adjourned their Regular Session, and that the Governor has until 10/09/2011 to sign or veto bills. He noted that President Obama has proposed the new American Jobs Act, which is expected to receive a lot of press and discussion over the next several weeks.
