Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday

November 8, 2011

The Chairman presented a proclamation declaring November as Adoptions and Permanency Awareness Month.

A commendation was presented to Chief Probation Officer Jerry Powers upon his leaving service from Stanislaus County.

John Mataka wanted to correct a statement that he made during the 11/01/2011 Board of Supervisors meeting regarding the number of people President Obama has deported during his administration. The correct number is 1 million, not 100. He also noted that over 400,000 people have been deported in 2011. He spoke regarding the public records request he made last week, and he awaits this information.

Emerson Drake encouraged everyone to vote today. He also spoke regarding election campaign reform and requested that the following changes be made: require a Board of Supervisors member to recuse themselves from a vote if they received a campaign contribution above a set limit, and prohibit elected officials from entering into a contract with a vendor who made contributions to their election campaign.
