Corr 1 Referred to the Department of Planning and Community Development and the Chief Executive Office, a letter from the City of Turlock requesting appointments to their Redevelopment Oversight Board – Successor Agency to the Turlock Redevelopment Agency.

Corr 2 Referred to the CEO, a letter from the Stanislaus Regional Water Authority requesting that the Board of Supervisors consider the appointment of two Board members to the Authority as a primary and an alternate Ex-officio Director.

Supervisor De Martini noted that he participated on the Election Observer Panel for the City of Modesto Municipal Run-off Election. He reported that the election was conducted orderly and professionally.

CEO Nino reported that the State Controller has released the January cash payments, and they are \$1.2 billion below the 2011/2012 State Budget estimates. Year-to-date, the State is \$3.7 billion short in their Revenue estimates. The County has sent a letter of support to the Senate Appropriations Committee for AB 324 which would clarify the responsibility for juvenile sex offenders belonging to the State Division of Juvenile Facilities. Senate President Pro-Tem Darrell Steinberg has committed to passing a pension reform package before the State Budget is adopted in this fiscal year. At the federal level, the House and the Senate are scheduled to be in session next week. President Obama released his FY 2013 Budget on Monday, and it totaled approximately \$3.8 trillion. She noted that transportation will continue to be a key issue for both the House and the Senate.
