The CEO noted that the State legislature is in recess. She reported that at the Federal level, the Joint Committee on Taxation released new information showing that both parties are struggling over \$51 billion in tax policy for the next fiscal year. This is the difference between the parties' plans for temporary extensions of the Bush tax cuts. She noted that our Federal lobbyists have had conversations with the House and Senate staff regarding agricultural interests, but they anticipate no action until after the election. The County legislative lobbyists have heard that House Republicans are moving forward on an idea to compromise on a continuing resolution for current spending, which would delay discussion until after the election.
