Chairman Chiesa recognized Supervisor O'Brien as the 2012 Chairman of the Board and thanked him for his leadership.

Congressman Denham welcomed the Board to a new year. He looks forward to a continued partnership with Stanislaus County, and ensuring that our local needs are represented in Washington D.C. He noted that he is on the Transportation Infrastructure Committee and Agriculture Committee, and that there are big issues coming up including opportunities to improve our local infrastructure and the Farm Bill.

Deahana Washington voiced concerns regarding illegal activity occurring at a property in the unincorporated area of the Marshall Ave. neighborhood.

Emerson Drake congratulated the re-elected Board members. He spoke regarding the Salida Annexation Ad Committee meeting that was recently canceled. He also spoke regarding animal abuse matters that have not been prosecuted.

Supervisor De Martini spoke regarding the need to revitalize Fairview Park. He noted that this is a neighborhood park, and the only one in the Bret Harte area. He plans to work with the County Parks Department and the Parks Commission to see what can be done to make improvements.

Chairman Chiesa thanked the Board for electing him as Chairman for 2013.

The CEO reported that the State Legislature is back in session. She gave an update regarding Assemblymembers Adam Gray and Kristen Olsen's committee assignments. The Governor plans to release the 2013-2014 State Budget on 1/10/2013. She noted that the 113<sup>th</sup> Congress was sworn into office last week. The fiscal cliff legislation was passed by Congress and signed by the President, and includes elements pertaining to personal income tax, the extension of unemployment benefits, prevents a 27% cut in Medicare reimbursements to doctors, and reauthorizes the federal farm program (including lowering the price of milk). However, the bill did not raise the federal debt ceiling or extend the payroll tax reduction.

The CEO introduced Kathy Harwell as the new Director of the Community Services Agency.
