The Board presented to Coach Trent Merzon certificates for the Oakdale Joint Union High School Varsity Football team as the 2012 NorCal Division II Champions.

The Board presented to Coach Roger Canepa and Principal Melissa Bengtson certificates for the Central Catholic High School football team for being the 2012 California International Scholastic Federation Division IV State Football Champions.

Emerson Drake voiced concerns that the time of the Workforce Alliance quarterly meeting was not properly noticed. He stated that the Alliance Director noted that he had a copy of the Goodwin study draft report regarding the proposed Salida Annexation. Mr. Drake requested a copy of this draft report.

Kathryn Borges spoke in opposition to the proposed annexation of Salida into the City of Modesto. She also voiced concerns regarding the Alliance having the draft Goodwin report when it has not been released to the public. She invited everyone to attend the Salida MAC meeting tonight at the Salida library at 7:00 p.m.

Supervisor Withrow and CEO Nino stated that they were not aware that the Alliance had received a copy of the Goodwin draft report and that they would follow-up on this issue. Supervisor O'Brien noted that he is a private member of the Alliance and he has not seen the Goodwin Report.

Monteith/O'Brien (2-1)(De Martini opposed)(Chiesa and Withrow abstained) **9:05 am** After conducting the public hearing, a motion to deny the appeal and to confirm the decision of the Planning Commission failed to receive an affirmative vote of a majority of all the members and, therefore, the following decision of the Planning Commission remains in effect: approval of a 5-year time extension to the Development Schedule for Rezone Application No. 2007-01, Santa Fe Crossing, an approved Development Plan P-D (313) that allows for the development of a commercial project consisting of a 19,250 square foot commercial building, 435 mini storage units, 52 RV storage spaces, a gas station with a 5,065 square foot mini market, and a drive through coffee shop, the 11.44± acre project site is located at 4306 Santa Fe Avenue, at the northwest corner of Geer Road and Santa Fe Avenue, southeast of the City of Hughson – Planning 2013-48

De Martini/Chiesa (2-1)(O'Brien opposed)(Withrow abstained)(Monteith absent) **9:10 am** After conducting the public hearing, a motion to sustain the appeal and to reverse the decision of the Planning Commission failed to receive an affirmative vote of a majority of all the members and, therefore, the following decision of the Planning Commission remains in effect: approval of Vesting Tentative Parcel Map Application 2006-44, Willms Ranch, LLC., a request to create 42 parcels, ranging in size from 40.0 to 69.9 acres, with a 277.7± acre remainder, from two (2) existing parcels totaling 2,383.83± acres in size located in the Sierra Nevada Foothills, on the west side of Willms Road, east of the City of Oakdale (APN: 011-013-001 & 006, 009, 011) – Planning 2013-49

Withrow/De Martini (4-0)(Monteith absent) **B11** Adopted the FY 2012-2013 Mental Health Services Act Plan (MHSA) Update; authorized the BHRS Director to submit the FY 2012-2013 MHSA Plan Update to the Mental Health Services Oversight and Accountability Commission; amended the Salary and Position Allocation Resolution to reflect the changes detailed in the Staffing Impact section of the agenda item; and, directed the Auditor-Controller to increase appropriations and estimated revenue in the amount of \$956,267 per the Budget Journal Form – BHRS 2013-50

Supervisor De Martini spoke regarding the importance of item *B6 on today’s agenda concerning the Monterey Park Tract Community Service District Water Connection Project with the City of Ceres. He noted that Monterey Park Tract has had water quality problems for years and that he is glad to see a permanent solution. He thanked the City of Ceres for allowing this community to hook up to their water system.

Supervisor O’Brien requested that a presentation be scheduled before the Board for an update on child welfare dollars and the Valley Recovery Center. He also spoke regarding the State’s rejection of Stanislaus County’s proposal for a Call Center (Health Benefit Exchange), and the award of this to Contra Costa County.

Chairman Chiesa reported that at CSAC’s Annual meeting, Cal/EPA presented the California Communities Environmental Health Screening Tool which compares the impacts of pollution on communities. He met last week with Cal/EPA Undersecretary Aresnio Mataka to address the intent of this Tool. The Chairman gave an update regarding the AB 109 allocation formula, and noted that there is a growth of \$77 million in this program, and a decision needs to be made by March regarding these funds. He noted that the AB 109 funding formula will be revisited in November 2013 for the following 2 years. He reported that MID will be holding hearings on 1/30/2013 and 1/31/2013 regarding the relicensing of the Don Pedro Project and noted the importance of people staying engaged with this issue.

Supervisor Withrow suggested that Board of Supervisors’ Reports be made at the beginning of meetings in the future.

The CEO reported that the Governor presented his State of the State Address last week, and he called for an extraordinary session regarding the federal Patient Protection and Affordable Care Act. She noted that Assemblymember Hall introduced AB 195 which would extend the sunset date of design build to 7/01/2020.

The CEO announced that the 2013 State of the County Address will be given by Chairman Vito Chiesa on Tuesday, 02/05/2013 at 9:00 a.m. in the Chambers – Basement Level at 1010 10th Street, Modesto, California.
