Supervisor De Martini reported that the Animal Services' Agency held a Dog License Amnesty Program in January and it was very successful with over 4,000 dogs licensed. The Amnesty program will be extended until the end of February.

CEO Nino reported that State Senator Cannella introduced SB 144. This bill proposes to redirect the savings the State is realizing from public safety realignment and send the money to counties on a preoffender basis. The bill does not make any changes to the current public safety realignment. The CEO gave an overview of this bill, and an update on the existing public safety realignment. She noted that the Legislative Counsel in Sacramento has until 02/22/2013 to complete the drafting of over 3,000 bills. At the federal level, the Violence Against Women Act has been re-introduced in the Senate. The Senate gave final approval to suspend the debt ceiling until May 2013. Senator Boxer, Chairwoman of the Senate Environmental and Public Works Committee, plans to introduce a new Water Resources Development Act bill, and we will try to include the Orestimba Creek Project in this bill.
