Chairman Chiesa reported that he will be attending a State Water Board hearing on 03/20/2013 regarding San Joaquin River flow proposal. The proposal by the State Water Resources Control Board would require the Merced, Tuolumne, and Stanislaus rivers to dedicate 35 percent of unimpaired flow to fish and wildlife from February to June each year. He noted that this is an important issue and if anyone needs more information they should contact TID or his office.

CEO Nino reported that last week the Assembly Budget Committee heard the proposal regarding the State option on Medicaid expansion. The State Department of Health Care Services wants to take a portion of the local government's 1991 realignment without any delay. She noted that the Assembly passed AB1X1 expanding Medi-Cal coverage for low income adults without children at home. The Transportation Coalition for Livable Communities proposes to use Cap and Trade auction revenues from fuels for transportation infrastructure investments. CSAC is coordinating a support letter regarding this issue. The CEO reported that last week Congress debated proposals to undo the Sequester. She also noted that Congressman Denham is looking ahead at a potential ag related field hearing at the end of May in Stanislaus County.
