A commendation was presented to William Bassitt, CEO of the Stanislaus Economic Development and Workforce Alliance, upon his retirement.

Frank Johnson of the NAACP presented to District Attorney Birgit Fladager the 2013 Diversity Award.

Sheriff Christianson updated the Board on the County's Inmate Roadside Program.

Vernon Lee Price, Homeless Advocate, stated that Homeless Helping the Community will be applying for a \$250,000 grant from the Department of Health and Human Services to reopen the facility on Scenic Drive in Modesto. He invited anyone interested to attend a meeting on 8/13/2013. He spoke regarding available BHRS programs for the homeless, and thanked the Board for their support.

Kathy Harris spoke on behalf of United Domestic Workers (UDW) Union, and reviewed the average income of In-Home Supportive Services (IHSS) Providers. She spoke in support of a wage increase for IHSS workers.

Emerson Drake spoke regarding campaign donations at the federal and local levels. He requested that the Stanislaus County Elections office post campaign donation statements online similar to the City of Modesto's practices.

Corr 2 Acknowledged receipt of claim and referred to the CEO-Risk Management Division the following claim: David Kuhlmann.

CEO Nino reported that the State Senate will remain on recess for another week and that the Assembly returned on Monday. There is an indication that the Governor may push for a plan to get the State Unemployment Insurance Trust Fund solvent again through a proposal to increase payroll taxes to employers. The fund currently has \$10 billion in federal debt, plus \$860 million in debt from State internal borrowing. On the federal side, the Senate and the House are adjourned until 09/09/2013. Last week, House leadership was unable to move the Transportation and Housing and Urban Development appropriation bill forward. This bill makes appropriations and provides for a wide range of programs in regards to equal employment opportunity, community development block grants, and Federal Housing administration.
