As the new County Assessor, Mr. Gaekle will receive the established salary for the office of Assessor, which is \$148,366.40 per year, plus the current benefit package for elected officials

O'Brien/Monteith unan. **B11** Approved the filing of a Notice of Exemption finding that the proposed project is exempt under provisions of CEQA pursuant to State Guidelines Section 15061(b)(3); approved the Stanislaus County Jail Needs Assessment 2013 Update prepared by Crout Criminal Justice Consulting, LLC; approved the use of \$445,000 in Public Facility Fees, as recommended by the Public Facilities Fees Committee and Capital Facilities Committee, along with the \$4 million previously authorized by the Board of Supervisors, bringing the total commitment for County funds to \$4,445,000. These funds are to be used solely as match for the Adult Local Criminal Justice Facilities Construction Financing Program (SB 1022) to match the requested \$40,000,000 in State Lease Revenue Bond Financing with the State of California Board of State and Community Corrections and the Department of Corrections and Rehabilitation; approved the use of Public Facility Fees, as recommended by the Public Facilities Fees Committee and Capital Facilities Committee, including the additional commitment of up to \$250,000 in Public Facility Fees for ineligible project costs; authorized the designation of the Chief

Operations Officer as the Project Manager; and authorize the Project Manager to finalize and submit the application pursuant to the Adult Local Criminal Justice Facilities Construction Financing Program (SB 1022) to the State of California Board of State and Community Corrections and the Department of Corrections and Rehabilitation for \$40,000,000 funded through State Lease Revenue Bond Financing; approved the formal Board of Supervisors Resolution required by the State for submission of the application; directed the Auditor Controller to establish an interest bearing Capital Project Fund for the SB 1022 Adult Local Criminal Justice Facilities Construction Financing Program for the Re-Entry and Enhanced Alternatives to Custody Training (REACT) Center Project; directed the Auditor Controller to increase other operating transfers out appropriations in the amount of \$4,000,000 in the Chief Executive Office-Plant Acquisition Budget and to increase operating transfers in the amount of \$4,000,000 to the SB 1022 Adult Local Criminal Justice Facilities Capital Project Fund; directed the Auditor Controller to increase other operating transfers out in the amount of \$445,000 in Fund 6402 Public Facilities Fees-Jails; increase operating transfers in the amount of \$445,000 in the SB 1022 Adult Local Criminal Justice Facilities Capital Project Fund; and, authorized the Project Manager to issue a Request for Proposals for professional architectural design services and return to the Board of Supervisors to recommend an award when appropriate upon award of the State funding – CEO 2013-511

County Counsel determined that Supervisors O'Brien, Chiesa, Withrow, and De Martini have disqualifying conflicts of interest with **D-2** because they all own agricultural property under Williamson Act contract or qualified to be under contract. Therefore, in order to establish a quorum to consider this matter, the Board invoked the rule of necessity and drew lots to determine which two Supervisors would participate in the decision. Supervisors Chiesa and De Martini drew long straws and thus participated in the decision.

De Martini/Monteith (3-0)(O'Brien and Withrow abstained) **D2** Finds the County received less than onehalf of the foregone property tax revenue pursuant to Government Code Section 16142(e) for the 2013-2014 FY; approved the implementation of AB 1265 (Formerly SB 862) to maintain Williamson Act Contracts including a reduction of property tax benefits by ten percent and a related reduction of the term of the contracts to nine years, to be effective for calendar year 2014; directed the Assessor, A/C, Treasurer-Tax Collector, and Director of Planning and Community Development to take all necessary steps to implement AB 1265 for the 2014-2015 FY including, but not limited to, making the appropriate modifications to all affected properties assessed values, modifying tax bills to reflect the assessment changes and supplemental fees associated with the reduced tax benefit, and recording any necessary notices; and, directed the County's CEO to determine pursuant to Government Code Section 16142(e), or as it may be amended, whether payment for the previous FY is less than one-half or exceeds one-half of the foregone general fund property tax revenue and, if it is less than one-half, direct the Assessor, A/C, Treasurer-Tax Collector, and Director of Planning and Community Development to take all necessary steps to implement AB 1265, or any legislation extending AB 1265, for FY 2014-2015 and beyond - Planning 2013-512

Supervisor De Martini reported that the West Side Health Care Task Force will hold their 4th annual Biggest Loser (weight loss) Contest on Thursday, 10/17/2013 at noon at the Patterson Unified School District's Administration Building.

Supervisor Withrow reported that he and the DA sent a letter to the Administrative Office of the Courts (AOC) expressing concerns regarding the selection process for the new courthouse site in Modesto and support for the I Street site as opposed to the 10th Street location. Supervisor Withrow is concerned with the lack of transparency and the lack of the county involvement in this process.

Supervisor O'Brien noted that the County tried to get involved with the courthouse selection process and was informed by the Courts that the County would not be allowed to participate.

Chairman Chiesa reported that he and Interim CEO Risen have been meeting regularly with the Courts. He noted that the choice has been made by the AOC, and he expressed the need for a new courthouse. He stated that the courts are worried that this funding may disappear.

Interim CEO Risen reported that today the Supreme Court rejected Governor Brown's appeal regarding State prison overcrowding and has been ordered to release 10,000 inmates by 01/27/2014. The Governor had over 805 bills on his desk this year, and he signed all but 96, which he vetoed. At the federal level, Congress is still working on a compromise regarding raising the debt ceiling. He reported that the County is okay in regards to the federal shutdown, provided it does not continue for more than another couple of weeks.
