Emerson Drake spoke regarding the acquisition of Emanuel Medical Center by Tenet, and hopes that the Workforce Alliance will monitor the layoff and rehire process of the affected employees. He asked what the County's contribution is to the Alliance. He requested that the LAFCO meetings be televised, and he voiced concerns regarding their recent decision concerning the City of Patterson's annexation. Chairman Chiesa responded that the County's contribution to the Alliance is approximately \$95,000.

Supervisor De Martini reported that this year StanCERA, the County's retirement system, was third in the nation and second highest in California for returns at 14.7 %. This raised the percent funded from 78% to 82%.

Chairman Chiesa reported that last week he along with the Chief Operations Officer, Sheriff and staff, went to Sacramento to apply for SB 1022 funding for a new jail. He noted that County did an excellent job in preparing for the presentation and they did an outstanding job.

CEO Risen congratulated Chairman Chiesa upon being elected as the First Vice President of CSAC. He noted the excellent job of StanCERA in managing our investments. He reported that the State Legislature is in recess this week, and that County staff is developing the legislative platform for 2014. He and the Director of Legislative Affairs met with Senator Galgiani last week to discuss challenges facing Stanislaus County. Supervisor Withrow is in Washington D.C. today with representatives from Turlock, Modesto and the Del Puerto Water District representing the recycled water project on the West Side. The County continues to work with Congress to include the Orestimba Flood Control Project in the Water Resources Development Act Bill.

The Chairman announced that there will be a Laird Regional Park Ribbon-Cutting on Thursday, 12/12/2013 at 12:00 p.m. to 2:00 p.m. at 8224 W. Grayson Rd., Modesto, CA. He also announced that on Tuesday, 12/17/2013 at 4:00 p.m. to 5:30 p.m. at the Kirk Lindsey Center, 1020 10th Street, Suite 102, Modesto, CA a public reception for CEO Stan Risen.
