CEO Risen reported that Governor Brown delivered the State of the State address which reinforced fiscal prudence. The Governor did not announce any new initiatives. The State legislature confirmed future leadership changes with Senator DeLeon to become the new Senate Pro Tem and Assemblymember Atkins as the new Speaker. The CEO noted that the ballot measure that would have increased vehicle license fees has been pulled from the ballot and will not be going forward this fall.
