Supervisor Chiesa reported that Governor Brown spent about 3 hours in Stanislaus County yesterday. He met with the Sheriff, DA, Chief Probation Officer and BHRS Director. The Governor spent time at the DA's office, the Psychiatric Health Facility, and Unit 2 at Public Safety Center. The funding issue for AB109 was discussed, and Supervisor Chiesa noted that this was a great opportunity for the County.

Supervisor O'Brien reported that the railroad plans to close Claribel Ave. near Riverbank this Thursday 2/27/2014 through Monday 3/3/2014 due to construction.

CEO Risen reported that last Friday was the deadline to introduce new bills for the State's 2013-2014 Legislative Session. So far, 2000 bills have been introduced in 2014. The Legislature released SB103, SB 104, AB79 and AB 80, which are drought relief packages totaling \$664 million, with the largest amount going towards integrated regional water plans.

The CEO announced that there will be a dedication and open house of the Stanislaus County Psychiatric Health Facility on Tuesday, 02/25/2014, 1:30 - 3:00 p.m., located at 1904 Richland Avenue, Ceres, CA.
