Regular Session All Supervisors Present Pledge of Allegiance to the Flag Tuesday March 18, 2014

Carmen Sabatino voiced concerns regarding a meeting held on 3/13/2014 where County staff provided information about the possible formation of a Municipal Advisory Council (MAC) for the Wood Colony Community. Supervisor Withrow noted that the County was approached by residents of the Wood Colony area about creating a MAC, and that it has been a community effort.

Amanda Sorenson noted that she attended the 3/13/2014 Wood Colony meeting and she found the County's presentation informational. She spoke regarding the potential annexation of Salida by Modesto, and noted that Salida still needs the County's support in preventing this.

Zach Couch, President of the Central California Sporting Dog Association, asked the Board for a letter of support for AB 2205, which would permit the use of dogs in hunting bears and bobcats.

Nanette Spyksma noted that she also received an invitation to the Wood Colony meeting, and that it is the members of the Wood Colony community that have requested the formation of a MAC.

Supervisor Chiesa reported that he is holding Turlock Government Night this Thursday, 3/20/2014, between 6:30 p.m. - 8:00 p.m., at CSU Stanislaus, Mary Stuart Rogers Building Room 130. He invited all to attend this event in which the following representatives from the Federal, State, County and City levels of government will be present: Congressman Jeff Denham, Assembly Member Kristin Olsen, Mayor John Lazar and himself.

Chairman De Martini spoke highly of County staff in successfully obtaining \$40 million in funding from the California Board of State and Community Corrections (BSCC) for jail construction funding under SB 1022. He noted that County staff performed beyond expectations and congratulated them upon a job well done.

CEO Risen reported that Chief Operations Officer Patricia Hill Thomas, Sheriff Christianson and the entire Capital Projects team did an amazing job in winning the appeal before the BSCC and obtaining the \$40 million funding. These funds will be used for the construction of a reentry facility at the Public Safety Center. He noted that this particular project gives us hope in replacing the downtown jail. It will allow the County to provide a higher level of programming services and training, and hopefully will result in a reduction in recidivism. The CEO noted that the State Department of Finance reported that revenues are tracking \$965 million above the State budget. In addition, the State as a whole has recovered 88% of the jobs lost during the recession.
