Carmen Sabatino spoke regarding the low turnout at an event yesterday that featured the candidates for the District Attorney. He voiced concerns about the driving activities of a black sedan after this event. He also voiced concerns about the Sheriff's SWAT Team, and the investigation of the Anthwal brothers in Turlock.

Dave Geer, former Modesto City Councilmember, voiced concerns about the new Common Core school curriculum and provided a book by Glenn Beck regarding this issue.

Emerson Drake spoke regarding the public comments made at last week's Board meeting, and his recent public records request to the County. Supervisor Chiesa reported that the CSAC Legislative Conference starts tomorrow in Sacramento, and there will be discussions regarding water, realignment and the Governor's May Revised Budget.

CEO Risen reported that the Governor released his May Revised Proposed Budget, in which revenues are projected to be up \$2.4 billion. This budget focuses on paying down debt and reducing long term liabilities, including placing \$1.6 billion aside for a rainy day fund, \$1.6 billion to pay off some economic recovery bonds, and funding to shore up CalSTRS. He noted that Medi-Cal has increased statewide by 46% after the implementation of Covered California and the Affordable Care Act, and that this budget reflects an additional \$1.2 billion to fund this Medi-Cal expansion.

Supervisor Chiesa noted that the May Revised includes \$100 million to pay back a portion of the money owed to counties, cities, and schools for mandated programs.
