Mary Burch spoke regarding last Thursday's Modesto Bee article concerning groundwater pumping. She voiced concerns regarding the membership of the Water Advisory Committee (WAC). She noted that her neighbors' wells have gone dry and that she is concerned for her well. Supervisor Withrow invited her to attend the next WAC meeting on 10/08/2014 at 6:00 p.m.

Carmen Sabatino spoke regarding two Superior Court cases that the County is currently involved with, and voiced concerns regarding the District Attorney's office.

Emerson Drake spoke regarding Mayor Marsh's comments concerning Wood Colony and Modesto's General Plan. He asked the Board for their continued support of Wood Colony community. He voiced concerns regarding groundwater pumping and noted he supports a moratorium for issuing well permits. He also spoke regarding MID supporting candidates in a local magazine.
