Matthew Machado, Director of Public Works and staff updated the Board on the North County Corridor Transportation Expressway and GIS

Phil McKay from the Department of Fish and Wildlife spoke on the impact of the homeless camps on the banks of the Tuolumne River. He stated that the litter left behind by the homeless ends up in the rivers. He invited the Board and general public to participate in a cleanup along Tuolumne River on 11/15/2014.

Vernon Price spoke about the HHS vouchers for the Tiki Motel. He said the hotel has drug issues. He would rather be allowed to go to the Vagabond Hotel which has a better atmosphere. He also spoke regarding the rights of the homeless on public property.
