Chairman De Martini spoke about the Adopt a Pet program and Stanislaus Animal Services staff presented a cat and dog that are eligible for adoption.

The Red Ribbon Week 2014 Best Decorated School Contest winners received their awards. Faith Conley from CSAC presented the CSAC 2014 Challenge Award for the Stanislaus County Employee Mentor Program to Norma Baker of the CEO's office.

Joan Rutschow spoke regarding the drought situation. She recommends a comprehensive plan with long term sustainability and a long term solution. She spoke in support of increasing water storage capacity and desalination plants.

Vernon Lee Price, homeless advocate, spoke regarding the storm coming later this week. He also noted that he provided information to the Board regarding SSI Advocacy in San Francisco.

Supervisor Chiesa reported that he and Supervisor Withrow attended a meeting in Ripon yesterday regarding new groundwater regulations with the Department of Water Resources, and Supervisors from Amador, Merced, San Joaquin, and Tuolumne counties. He noted that today is City of Turlock Mayor John Lazar's last day after 22 years of public service. He spoke highly of Mayor Lazar and noted that he looks forward to working with Mayor Gary Soiseth in the future.

Chairman De Martini reminded everyone that tomorrow is the last day for paying property taxes. He reported that StanCERA, the County's retirement system, had its best year last year with net earnings on investments of \$234 million, which is better than a 17% return.

CEO Risen reported that the State Legislature is back in session, and they are in the process of establishing new bills that will be introduced. At the federal level, there are last minute negotiations to introduce a \$1.1 trillion spending bill to avoid a government shut down this week. In the past, when we have had federal government shutdowns, it did not have a significant impact at the County level.
