Supervisor Chiesa requested that StanCERA give a presentation regarding their Annual Financial Report to the Board of Supervisors.

Supervisor O'Brien congratulated Supervisors Monteith and Withrow, as well as the other County elected officials, upon their swearing-in today. He congratulated Supervisor Withrow upon being elected Chairman of the Board for 2015. He also thanked his wife for attending the meeting today, and noted the impact that public office has on the families of elected officials.

The CEO congratulated all the elected County officials that were sworn in this morning. He reported that the State legislature is back in session, and that Governor Brown was sworn into office yesterday. In his address, the Governor announced his intention to gain bipartisan support to deal with the underfunding of highway maintenance. The Governor also wants to make sweeping changes to address global warming, and intends to create 2030 objectives on greenhouse gas reduction, including increasing the amount of electricity from renewals up to 50%, and reducing vehicle petroleum use by 50%.
